This amendment is issued to provide the following information:

1. "Spec Section 33 30 00.00 20,2.11 calls for the 4" schedule 40 to be coated inside and outside with apparently a coal tar coating. From the detail on sheet C-03, the fittings appear to be welded, and would need to be fabricated in some way to produce the angles shown in the detail. The internal coating spec'd cannot be reapplied properly after welding, to the inside of the assembly. Is another protective system possible for the protection required? Please give direction on how to proceed."

-- The vent pipe shall be coated with a two-part epoxy paint system compatible with domestic sewer environment. Pipe shall be coated inside and outside. Contractor shall touch up paint, if required, after welding.
