Question 1: Note 9 on Sheet A-101 states " wall bumper and handrail - match existing - to be provided by the government." Note 12 states "crash rail, end 6" from obstructions - see detail 5/A-501. Will the crash rails be provided by the government also? Please provide direction on how to proceed.

Answer 1: The Wall and Handrail referred to in note #9, Sheet A-101, is provided by the Government. The Crash rails referred to in note #12, Sheet A-101 shall be provided by the Contractor.

Question 2: Review of the contract and discussion with subs and suppliers indicate we need more time to complete this project. Please consider and add an additional 90 days (total 210), for submittals and material procurement and so work can be accomplished. Also, can the proposal due time be extended to 3 PM the same day to move from the 12:00 o'clock hour. This time is difficult to get sub/supplier numbers at times and 3 will miss the currently scheduled bids for the day.

Answer 2: CCD is extended to 270 days after award. The time for receipt of proposals is changed to no later than (NLT) 1500, 19 September 2011.
