1. Question: Can specs be issued for the epoxy flooring on this project? Please advise.

1. Answer: Contractor shall provide a standard resinous seamless flooring comprised of: brightly colored quartz broadcast; a three-component, solvent free epoxy undercoat consisting of resin, curing agent and filler; brightly colored vinyl flakes; A two-component, solvent free, high performance, UV resistant, clear epoxy sealer. Physical characteristics: Nominal 2mm thickness; Tensile strength 5,200 psi (ASTM C-307); Hardness 85 to 90(ASTM D-2240, Shore D); Bond Strength >400 psi (ASTM D-4541) (100% concrete failure); Impact Resistance >160 in./lbs.(ASTM D-2794); Abrasion Resistance 0.06 gm max. weight loss(ASTM D-4060, CS-17); Cure Rate 12 hours for foot traffic(@ 77°F/25°C) 24 hours for normal operations; Coefficient of Friction (Dry) 0.79 (ASTM F-1679); Slip Resistance Index (Wet) 0.65 (ASTM F-1679). Install per manufacturer's recommendations.
